#### 1. About the ICN

# 2. Project Purpose and Description

The Inspiring Action for Global Citizenship program is funded by Global Affairs and implemented by the eight provincial and regional councils for international cooperation from 2019 to 2026. The initiative aims to increase awareness and engage the Canadian public as global citizens in support of the Feminist International Assistance Policy (FIAP), Canada's Policy for Civil Society Partnerships, and Canada's commitment to the Sustainable Development Goals (SDGs). Additionally, it aims to strengthen the effectiveness of Canadian civil society organizations and their local partners to deliver sustainable results in support of Canada's international development priorities. The IAGC program integrates lessons learned from the experiences of the Inter-Council Network (ICN) as well as the eight councils.

The consultant will work closely with the ICN National Program Manager and the ICN MEL committee members to prepare a written report, based on collected stories of change from the past 6 years of the IAGC program.

The successful candidate will begin work in mid-November 2024 and will collect, analyze, review and code each council's capacity development stories from Year 1 through Year 6 of the IAGC program.

### 3. The Opportunity

The ICN is currently seeking a consultant with relevant experience and interest to support the ICN Monitoring & Evaluation (MEL) Committee in analyzing *Stories of Change* for our *Inspiring Action for Global Citizenship* Program Outcomes Reporting for Global Affairs Canada (GAC).



The process will include a review of existing material (Stories of Change) collected from all Councils in English and French, over a 6-year period; analysis of key themes across the material; selection of stories, in collaboration with the ICN MEL Committee, to showcase the identified key themes; and a final written report in English.

# 4. Thematic Analysis Process

The consultant will produce the following as part of the agreement:

- Select 15 stories to help understand the content, range and diversity within and amongst the stories. Determine key emerging themes from these stories which will serve to structure the content analysis.
- Determine the 3-4 most significant or recurring topics, ideas or themes. This could include crosscutting themes as well as unique or unexpected themes that collectively speak to learning related to project outcomes and impact.
- Read, label and code all the stories of change (approximately 100 Capacity Development Stories in Y6) using the identified themes. Qualitative analysis software such as Nvivo or AI tools that assist with identifying themes could be used to facilitate the process. In order to focus on learnings across the Councils, a human-centered approach will also be important.
- Showcase key stories under each of the themes (approximately 3-4 stories for each theme) to ensure that Stories of Change are representative of a broad range of activities and work, ranging across all Councils and years of the IAGC program.
- Review stories to develop the thematic analysis sections. This will support the clarity and consistent application of themes throughout the analysis. Key insights and examples from the stories will be included in the analysis section, summarizing how each theme relates to the Stories of Change.
- Prepare a report, including the introduction, methodology, three to four thematic sections
  which each include a thematic analysis, a lesson learned section, a conclusion and annex of all
  coded stories of change.

### **5 Consultant Profile**

The ideal Consultant will:

Must be bilingual; fluent in English and French (required);



- Clearly demonstrate experience with monitoring, evaluation and learning, in particular conducting qualitative analysis, narrative and/or thematic analysis, ideally for non-profit organizations;
- Be familiar with the international cooperation and global education sectors in Canada;
- Demonstrate relevant experience working with non-government organizations (NGOs), including small and medium-sized organizations (SMOs), government funders and/or other actors in the international cooperation sector;
- Have excellent communication, organizational, writing, and analytical skills;
- Have proficiency with Windows and Microsoft Office Suite, Google docs, and Zoom;
- Work creatively and within budget to achieve desired results within the anticipated time frame;
- Be available for ongoing check-in meetings/discussions at key moments between October 2024 and March 2025.

#### 6. Deliverables

The successful consultant will work collaboratively with the ICN Monitoring, Evaluation and Learning (MEL) Committee to produce a report (written in English) which will include the following sections:

- Introduction (1 page)
- Methods and Approach (1-2 pages)
- Theme 1 analysis / narrative (2-3 pages)
- 3-4 Stories of Change showcasing Theme 1 (length varies)
- Theme 2 analysis / narrative (2-3 pages)
- 3-4 Stories of Change showcasing Theme 2 (length varies)
- Theme 3 analysis / narrative (2-3 pages)
- 3-4 Stories of Change showcasing Theme 3 (length varies)
- Lessons Learned (1-2 pages)
- Conclusion (1 page)
- Annex / Compendium of Stories of Change

The ICN MEL Committee will support the consultant by:

- Providing oversight of the process, ensuring alignment with GAC reporting requirements;
- Providing access to relevant material (Stories of Change) collected by Councils over a 5–6-year period, including additional relevant data or interview material, as needed.
- Supporting analysis of key theme findings, in collaboration with the consultant.
- Reviewing and agreeing on the overall structure, method and approach.
- Sharing ongoing feedback on the process, including draft version(s) of the final report.

#### 8. Submission of Interest Guidelines

Submissions of interest must include the following:

- 1) **Cover letter** stating interest in the project, qualifications and experience with qualitative analysis and/or narrative approaches to evaluation
- 2) CV outlining previous experience with monitoring and evaluation and learning and in particular conducting qualitative, narrative or thematic analysis.
- 3) **Budget** outlining the number of days required for the work and the daily rate.
- 4) Online web pages and/or two to three examples of related pieces of work.
- 5) Explain your availability between October 2024 and March 2025, including any black-out period
- 6) Complete contact information for three recent and relevant professional references.
- 7) Indicate whether you are eligible to work in Canada (verification will be required by the selected consultant(s)).

# 9. Remuneration – The contract will be awarded in three stages

- 1) 10% upon signing of a contract, confidentiality agreement and waiver of intellectual property rights involved in project completion.
- 2) 50% upon completion of presenting the first draft of the project
- 3) 40% upon completion of all agreed upon contract deliverables

# 10. Submission of Interest Evaluation Criteria

Proposals will be evaluated on the following criteria:



- Capacity of collecting, analyzing, reviewing, coding the data from various sources
- O Proven ability to work within timelines
- o Budget
- O Stories of change analysis, review and code development and reporting qualifications, experience with the subject matter of international cooperation, expertise in public engagement
- O Ability to work in both official languages is a requirement to the application
